PROM AGREEMENT

Dear parent or guardian, the below policies are specifically designed to help ensure your Teenagers' prom night is both safe and enjoyable. Our policy regarding drugs and alcohol complies with the applicable laws in the State of Georgia. We appreciate you in assisting us in reviewing the following regulations with your son/daughter.

1. All pickup and drop off locations must be predetermined and/or approved by the parent or guardian executing this agreement. Your chauffeur will be instructed to obtain permission of a parent or legal guardian in the event of any changes to the itinerary. A contact phone number must be provided to your chauffeur on or prior to the date of service in the event of any questions.
2. At all times the privacy divider in the limo will be locked open.
3. The following are strictly prohibited and any violation thereof is subject to immediate termination of our service.

- ___ Smoking tobacco or any other substance is prohibited inside our vehicles;
- ___ Drinking alcoholic beverages of any type inside our vehicles are prohibited;
- ___ Carrying and or storing alcoholic beverages of any type inside our vehicles are prohibited;
- ___ Consuming any type of illegal drug is prohibited;
- ___ Having intimate relations in our vehicles is prohibited;
- ___ Hanging any portion of body out the windows is prohibited;
- ___ Vandalizing, damaging, staining, breaking any part of the vehicle, including the interior, exterior as well as glasses and other items in or on the vehicle are prohibited and subject to additional charges for repair/replacement of damages. If anything is broken there is a \$100 minimum charge. If anyone gets sick in the car there is a \$500 clean up charge.

Note: In the event of any violations of the above regulations, our chauffeur will immediately terminate his service and all passengers will be dropped off at the initial pickup point or at a safe location. Authorities may be contacted in the event of any violations listed below and parents will be contacted immediately. In the event of any cancellations of the rental, the total contract price will be charged. No refunds are given and all deposits are non-refundable.

On behalf of my child and myself each of the undersigned hereby:

1. Waive, release, and discharge Empress Elite Limousine, LLC, its employees, agents and contractors, from any and all claims relating to my child's participation in prom activities and limousine service provided;
2. Assume any and all risks of property damage to the vehicle, and release and hold harmless Empress Elite Limousine, LLC from any all liability for personal or property damage;
3. Indemnify and hold Empress Elite Limousine, LLC harmless from any loss, liability, damage, cost or expense, including litigation, which may incur as a result of any personal or property damage which my child participated in while in the vehicle;

4. Reimburse Empress Elite Limousine, LLC for any damages to equipment or accessories including but not limited to, stereo system, speakers, drinking glasses, television, upholstery, windows, etc.

Empress Elite Limousine, LLC wants to ensure a safe and memorable prom night for your teen. With that goal in mind please help us by reviewing these rules with your child and ensure that they know any violations could place their limousine charter in jeopardy.
